Rules & Regulations

- I agree to abide by all the rules, regulations, dojo etiquettes, and procedures of the organization 'Japan Karate-Do Nobukawa-ha Shito-Ryu Kai India (Japan Karate-Do Shito-Ryu International Renshikan)' (Henceforth organization will be referred to as JKNSKI) and agree that rules and regulations may be modified or updated from time to time.
- I am aware and agree that physical contact will be used by the principal instructor, instructors, examiners, officials, students, and authorized individuals of JKNSKI during teaching, training, testing, demonstrations, competitions, seminars, camps lectures, etc. for which I have full consent to any physical contact as may be required or essential to martial arts, self-defense training or for the first aid.
- The JKNSKI teaches a highly technical advanced form of Japanese martial arts 'Nobukawa-ha Shito-Ryu Karate-Do' to its students hence students should remain respectful, sincere, and loyal towards the JKNSKI and its Principal / Chief Instructor, Technical Director & Instructors.
- The JKNSKI student is not allowed to teach martial arts or join any other style without the written permission of the Principal Instructor, Technical Director of Japan Karate-Do Nobukawa-ha Shito-Ryu Kai India (Japan Karate-Do Shito-Ryu International Renshikan) if found disciplinary action will be taken which can lead to expulsion or suspension and not allowed to teach within 50 km radius of our Dojo (JKNSKI training center) during the term of this contract and a period of 10 years following dissociation with JKNSKI.
- I have NO OBJECTION and willingly like to apply for DAN GRADE EXAMINATION process for my-self / child/ward at Japan Karate-Do Nobukawa-ha Shito-Ryu Kai India (Japan Karate-Do Shito-Ryu International Renshikan) and also agree that participation in EXAM does not guarantee success and all decisions regarding the examination by NARESH SHARMA (Principal Instructor & Licensed Examiner of JKNSKI) are accepted by me.
- I agree that Examination fees are payable in advance along with the form and also aware and agree that FEES ONCE PAID SHALL NOT BE REFUNDED IN ANY CASE. (Students who are absent due to emergency & who are detained are allowed to reappear for examination after one month and shall not pay any fees).
- I understand and am aware that 'Karate-Do' is primarily a martial art and a hazardous contact sport and my participation in Karate-Do training, testing, examinations, demonstrations, or for any unforeseen circumstances that can lead to any injuries (both minor or major), mishap and in some case even loss of life and by signing this registration form I agree to accept full responsibility for my-self / child/ward and declare that JKNSKI and its Principal Instructor, Technical Director, Officials, Instructors, Volunteers shall NOT be held responsible in any case. I will not indulge in any unlawful activity or action that might harm anyone or damage the prestige and honor of Karate-Do, Karate organization JKNSKI, or the institution where the training is conducted.
- I am aware that Karate-Do is primarily a martial art and I agree to act with full responsibility and shall NOT MISUSE it. I will only use my martial arts skills in case of danger or emergency for SELF-DEFENSE and protection FOR MY FAMILY & NATION according to the laws of the land. I also have NO OBJECTION if JKNSKI or its officials use my –self/child/ward's pictures, videos, names, etc. as advertisement material through the newspaper, internet, brochures, and banner or in printed or electronic form.
- I also agree and am aware that Karate Competition, Seminar, Camps, Kyu, and Dan Grade Certifications issued to validate the education, training, and level achieved in the style/art being practiced and is not valid for any govt. jobs, admission to schools, colleges, etc.
- I also agree that misconduct and violation of the rules, and regulations, damaging the reputation and prestige of Japan Karate-Do Nobukawa-ha Shito-Ryu Kai India (Japan Karate-Do Shito-Ryu International Renshikan) by, my child/ward led to disciplinary action in the form of stern punishment, penalty and in some case, even legal action will be taken against me, my child/ward.
- The Japan Karate-Do Nobukawa-ha Shito-Ryu Kai India (Japan Karate-Do Shito-Ryu International Renshikan) reserves all rights to terminate the membership of JKNSKI, withdraw, cancel, discard all the tests conducted and certificates issued without assigning any explanation or reason if any of JKNSKI student involved in any anti organization activities.
- The JKNSKI can modify the TEST / EXAMINATION schedule, if necessary, this may include altering the current examination schedule without giving any other reasons, or intimations.
- The JKNSKI does not warrant that the use of protective equipment will eliminate the possibility of injury or accident but shall reduce the risk of injury or accident. In recognition of the possibility of injury or accident connected with martial arts training in JKNSKI, I waive all my rights or causes of any action arising from such activities and any liabilities against the JKNSKI, its volunteers, Instructors, Principal / Chief Instructors, Technical Director, Employees, and the managing committee. Students must carry their Karate-Do Uniform and complete the Karate Kit (Gloves, shin pad, Headgear, Chest guard, Gum shield, etc.) required for training or testing.
- I agree and understand that participation in training, KYU / DAN grade examinations, competitions, training camps, seminars, and workshops is a mandatory part of Karate-Do learning and training which can't be omitted.
