## RULES & REGULATIONS FOR INSTRUCTOR'S REGISTRATION

- A Blackbelt holder of JKNSK INDIA wants to become a Karate Instructor then she/he must APPLY FOR INSTRUCTOR AUTHORIZATION to the Naresh Sharma Kyoshi requesting to join Japan Karate-Do Nobukawa-Ha Shito-Ryu Kai-India (JKSIR) as an instructor.
- An individual who desires to become an instructor must undergo an instructor's training program and also update regularly teaching and training methods under the guidance of JKNSK INDIA held training program and events.
- The JKNSKI (JKSIR) authorized Instructor should teach and work as a part of Japan Karate-Do Nobukawa-Ha Shito-Ryu Kai-India (Japan Karate-Do Shito-Ryu International Renshikan) and not independently.
- The JKNSKI (JKSIR) authorized Instructor should send the renewal fee to the Naresh Sharma Kyoshi given on the expiry date of Dojo, Dist. & State authorization. No Instructor or student has a right the claim renewal of the certificates as a matter of right.
- Kyu/Dan grade results will be given only from Japan Karate-Do Nobukawa-Ha Shito-Ryu Kai-India (Japan Karate-Do Shito-Ryu International Renshikan) HONBU DOJO INDIA (MAIN DOJO) & only Naresh Sharma Kyoshi shall do the grading test of various belts.
- All grading test papers shall be sent from the dojo, district, or state office to Naresh Sharma Kyoshi or submitted to his authorized Instructor Examiner before the test and the instructor of the students should also be there at the time of belt examination.
- Your progress and also the progress of your karate students in your DOJO/ AREA/ STATE will be monitored by the Japan Karate-Do Nobukawa-Ha Shito-Ryu Kai-India (Japan Karate-Do Shito-Ryu International Renshikan) and its Chief Technical Director-India Naresh Sharma Kyoshi as per rules & regulations of the Japan Karate-Do Nobukawa-Ha Shito-Ryu Kai-India (Japan Karate-Do Shito-Ryu International Renshikan) to consider an extension of your further authorization to teach.
